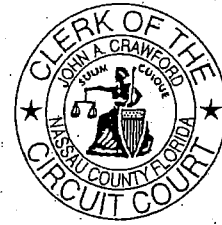




To Whom it May Concern:

HOW TO REGISTER AS A PREMARITAL PREPARATION COURSE PROVIDER

(Florida Statute Section 741.0305)

INSTRUCTIONS

1. Read Florida Statute 741.0305 (attached)
2. Complete the required attached "Registration Affidavit for Premarital Preparation Course Provider" and sign it before the Clerk of the Court, a Deputy Clerk, or a Notary Public.
3. A copy of ordination papers, if applicable, and/or all relevant training certifications are required to be sent along with your completed registration affidavit.

Florida Statute Section 741.0305

741.0305: Marriage fee reduction for completion of premarital preparation course.

- (1) A man and a woman who intend to apply for a marriage license under s.741.04 may, together or separately, complete a premarital preparation course of not less than 4 hours. Each individual shall verify completion of the course by filing with the application a valid certificate of completion from the course provider, which certificate shall specify whether the course was completed by personal instruction, videotape instruction, instruction via other electronic medium, or a combination of those methods. All individuals who complete a premarital preparation course pursuant to this section must be issued a certificate of completion at the conclusion of the course by their course provider. Upon furnishing such certificate when applying for a marriage license, the individuals shall have their marriage license fee reduced by \$32.50.
- (2) The premarital preparation course may include instruction regarding:
- (a) Conflict management.
 - (b) Communication skills.
 - (c) Financial responsibilities.
 - (d) Children and parenting responsibilities.
 - (e) Data compiled from available information relating to problems reported by married couples who seek marital or individual counseling.
- (3) (a) All individuals electing to participate in a premarital preparation course shall choose from the following list of qualified instructors:
- 1. A psychologist licensed under chapter 490.
 - 2. A clinical social worker licensed under chapter 491.
 - 3. A marriage and family therapist licensed under chapter 491.
 - 4. A mental health counselor licensed under chapter 491.
 - 5. An official representative of a religious institution which is recognized under s.496.404 (19), if the representative has relevant training.
 - 6. Any other provider designated by a judicial circuit, including, but not limited to, school counselors who are certified to offer such courses. Each judicial circuit may establish a roster of area course providers, including those who offer the course on a sliding fee scale or for free.
- (b) The costs of such premarital preparation course shall be paid by the applicant.
- (4) Each premarital preparation course provider shall furnish each participant who completes the course with a certificate of completion specifying the name of the participant and the date of completion and whether the course was conducted by personal instruction, videotape instruction, or instruction via other electronic medium, or by a combination of these methods.
- (5) All area course providers shall register with the clerk of the circuit court by filing an affidavit in writing attesting to the provider's compliance with the premarital preparation course requirements as set forth in this section and including the course instructor's name and qualifications, including the license number, if any, or, if an official representative of a religious institution, a statement as to relevant training. The affidavit shall also include the addresses where the provider may be contacted.

MARRIAGE LICENSE REQUIREMENTS

- You both have to be present to apply.
- You must be 18 years or older.
- Bring in Drivers License for proof of age and also Social Security Card (for United States Citizens).
 - Birth Certificate (for proof of age only)
 - State ID Card
 - Passport
 - Military ID
- If you have been widowed or divorced within the past six (6) months, you must provide the month/day/year that the marriage ended.
- Effective January 1, 1999, Chapter 741, Florida Statutes was amended adding the Marriage Preparation and Preservation Act of 1998, which provides for a marriage license fee reduction of \$32.50, (from the normal rate of \$93.50) for couples who complete a certified marriage preparation course. The Clerk's Office maintains a list of registered course providers. For Florida residents who file certification that they *both* have completed a state-sanctioned marriage preparation course within the past 12 months, there is no waiting period along with the reduced fee. For Florida residents who have not taken the course, there is a full three-day waiting period between issuance of the license and the time it becomes valid for use. The parties may take the course separately, they are not required to take it together, but **both** must take it in order to qualify for the discount and **both** must read a 16 page Family Law Handbook (copy provided by the Clerk's Office).
- The waiting period does not apply to nonresidents of Florida. If one party is a resident of Florida and the other party is a nonresident the three-day waiting period is waived *only* if the Florida resident takes the state-sanctioned marriage preparation course, but no discount is given. If both parties are nonresidents of Florida, and **both** parties take the course, the discount applies.
- A three-day waiting period applies for those who do not complete the certified marriage preparation course (unless both of the applicants show proof of out-of-state residence).
- The marriage license is good for 60 days anywhere in the State of Florida.
- If you wish for the Clerk's Office to marry you, it is an additional \$30.00 Clerk's fee and we ask for a 24-hour appointment in advance.
- The Clerk's Office performs weddings between the hours of 9:00 a.m. to 11:00 a.m. and from 2:30 p.m. to 4:00 p.m., Monday through Friday (except for legal holidays).

Florida Statute Section 741.0305

741.0305: Marriage fee reduction for completion of premarital preparation course.

(1) A man and a woman who intend to apply for a marriage license under s.741.04 may, together or separately, complete a premarital preparation course of not less than 4 hours. Each individual shall verify completion of the course by filing with the application a valid certificate of completion from the course provider, which certificate shall specify whether the course was completed by personal instruction, videotape instruction, instruction via other electronic medium, or a combination of those methods. All individuals who complete a premarital preparation course pursuant to this section must be issued a certificate of completion at the conclusion of the course by their course provider. Upon furnishing such certificate when applying for a marriage license, the individuals shall have their marriage license fee reduced by \$32.50.

(2) The premarital preparation course may include instruction regarding:

- (a) Conflict management.
- (b) Communication skills.
- (c) Financial responsibilities.
- (d) Children and parenting responsibilities.
- (e) Data compiled from available information relating to problems reported by married couples who seek marital or individual counseling.

(3) (a) All individuals electing to participate in a premarital preparation course shall choose from the following list of qualified instructors:

1. A psychologist licensed under chapter 490.
2. A clinical social worker licensed under chapter 491.
3. A marriage and family therapist licensed under chapter 491.
4. A mental health counselor licensed under chapter 491.
5. An official representative of a religious institution which is recognized under s.496.404 (19), if the representative has relevant training.
6. Any other provider designated by a judicial circuit, including, but not limited to, school counselors who are certified to offer such courses. Each judicial circuit may establish a roster of area course providers, including those who offer the course on a sliding fee scale or for free.

(b) The costs of such premarital preparation course shall be paid by the applicant.

(4) Each premarital preparation course provider shall furnish each participant who completes the course with a certificate of completion specifying the name of the participant and the date of completion and whether the course was conducted by personal instruction, videotape instruction, or instruction via other electronic medium, or by a combination of these methods.

(5) All area course providers shall register with the clerk of the circuit court by filing an affidavit in writing attesting to the provider's compliance with the premarital preparation course requirements as set forth in this section and including the course instructor's name and qualifications, including the license number, if any, or, if an official representative of a religious institution, a statement as to relevant training. The affidavit shall also include the addresses where the provider may be contacted.
